Note to Funeral Directors

All fees must be paid within 21 days of the Interment. Late payment may result in additional costs being incurred.

All applications for new graves must be signed by the person who will become the grave owner.

If additional graves are required for family members these must be reserved at the same time to guarantee availability of consecutive graves. Applications for each grave must be completed and signed by the person it is intended for. Full Names and Addresses must be provided.

If the application is in relation to someone under the age of 18, the parent or guardian must sign. Please be aware grave reservations are only valid for a period of 40 years. Also if someone subsequently moves from Skegness, significant additional costs may be incurred when the grave is put into use.
