Forms of nomination for the Lincolnshire County Council Elections may be obtained from the Deputy Returning Officer for East Lindsey District Council who will, at the request of an elector for the respective Electoral Division, prepare a nomination paper for signature. Given the restrictions associated with Covid-19, any request for nomination papers should be made via email at nominations@e-lindsey.gov.uk or telephone 01507 601111.
4. Nomination papers must be delivered **by hand** to the Deputy Returning Officer, East Lindsey District Council, Room 3, Tedder Hall, Manby Park, Louth, LN11 8UP on any day after the date of this Notice but no later than **4pm on Thursday 8 April 2021**. Given the restrictions associated with Covid-19, **it will be necessary for candidates to make an appointment** with the Deputy Returning Officer in order that their nomination can be handed in by this deadline. Any request for an appointment should be made via email at nominations@e-lindsey.gov.uk or telephone 01507 601111.
5. If an election is contested the poll will take place on **Thursday 6 May 2021**.
6. Applications to register to vote must reach the Electoral Registration Officer, East Lindsey District Council, Room 3, Tedder Hall, Manby Park, Louth, LN11 8UP by **midnight on Monday 19 April 2021**. Applications can be made online: www.gov.uk/register-to-vote
7. New applications for, amendments or cancellations of postal votes and amendments or cancellations of existing proxy votes must reach the Electoral Registration Officer, East Lindsey District Council, Room 3, Tedder Hall, Manby Park, Louth, LN11 8UP no later than **5pm on Tuesday 20 April 2021**, if they are to be effective for this election.
8. Applications to vote by proxy at this election must reach the Electoral Registration Officer, East Lindsey District Council, Room 3, Tedder Hall, Manby Park, Louth, LN11 8UP no later than **5pm on Tuesday 27 April 2021**, if they are to be effective for this election.
9. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer, East Lindsey District Council, Room 3, Tedder Hall, Manby Park, Louth, LN11 8UP by **5pm on Thursday 6 May 2021**. The physical incapacity must have occurred after **5pm on Tuesday 27 April 2021**. To apply on the grounds of occupation, service or employment, the person must have become aware that they cannot go to the polling station in person after **5pm on Tuesday 27 April 2021**.
